PROGRAMS AND SPECIAL EVENTS

January 6, 2019 – Lecture by local lawyer, Doug Stiles, on his family's connection to one of Abraham Lincoln's personal watches.

February 12, 2019 – Birthday bash and trivia night celebrating Abraham Lincoln.

February 22, 2019 – In honor of Black History Month, the Waukegan Historical Society brought their pop-up exhibit on African American history in Waukegan. Bryan Escobar, our Arts and History Specialist presented at Waukegan Public School's event: Black History Experience.

February 28, 2019 – Beverly Mallard, longtime voluntary head research librarian for the historical society was awarded the Jack Benny Arts and Humanities Award from the Waukegan Park District in recognition of her tireless dedication and more than 30,000 hours she has given to society researchers.

March 13, 2019 – Ty Rohrer delivers a presentation entitled: "Influential Women of Waukegan's Past" to the Zion Genealogical Society.

March 16, 2019 – Waukegan Historical Society participates in the Illinois Reads Book Festival and later helps to dedicate Ray Bradbury Park as a National Literary Landmark.

April 26, 2019 – The Illinois State Historical Society awards the Waukegan Historical Society with superior recognition for outstanding local history honoring the Top Fifty Events in Waukegan's History.

May 19, 2019 – Chandra Sefton, a lifetime member of the society and exceptional volunteer presented a program to our members on her family connection to the Legacy of the Simpson Brothers.

June 1, 2019 – Waukegan Park District's 20th Annual Ray Bradbury's *Dandelion Wine* Fine Arts Festival. The Waukegan Historical Society was proud to sponsor a stage, create an exhibit, and sell memberships and historical photographs at the festival.

June 15, 2019 – The Waukegan Historical Society was a proud sponsor of the Juneteenth Celebration. The Society had their African American History Exhibit on Display at the Festival.

June 29, 2019 – A free tour of Waukegan Harbor was provided by the Waukegan Historical Society.

July 12, 2019 – The history hidden in several of Waukegan's parking lots was unveiled during this free walking tour provided by the Waukegan Historical Society.

August 8, 2019 – Lunch and Learn on Finding Waukegan in Ray Bradbury's *Dandelion Wine*.



Actors, in period attire, told the stories of one of the first African American families, a mayor who brought industries to Waukegan, a noted Waukegan actress, and several more.

October 6, 2019 – The Historical Society's biggest fundraising event was a huge success. 491 people attended the tour, which featured Tudor-style homes never before open to the public in the fifty-one year history of the tour.




December 3, 2019 – Waukegan Historical Society's Holiday Open House at the Waukegan History Museum.

Congratulations Ann Darrow

Ann Darrow, Life Member of the Society, long-time volunteer for both the Research Library and Museum, and founding member of the Oakwood Cemetery Walk, was recently recognized for her dedication to Waukegan's history by both the Illinois State Historical Society and the Waukegan Park District.

Ann received the Lifetime Achievement Award from the Illinois State Historical Society, which is given to an individual for sustained and varied contributions to state and local history. The Waukegan Park District recognized Ann with the Jack Benny Arts & Humanities Award. Ann is definitely deserving of both of these prestigious distinctions.

Ann has volunteered in numerous roles for the Historical Society for over 30 years. She is an integral part of the Research Library and is our resident genealogical specialist.

Most importantly for the community, Ann Darrow has dedicated over twenty-five years of her life to the research of Waukegan's Oakwood Cemetery. She found that the City of Waukegan records on the cemetery were lacking. She took it upon herself to create a master database of records, and she has graciously shared this database with the City of Waukegan. Ann is the driving force for collecting and maintaining accurate records pertaining to Oakwood Cemetery and she is the primary contact for the City of Waukegan and for the public on all matters relating to the cemetery.

Ann is a pillar in the successes of the Waukegan Historical Society and Oakwood Cemetery Walk. Her dedication to the preservation as well as showcasing of Waukegan's history is truly amazing. Congratulations Ann!
